The meeting was called to order by the President, Bud Wood. Nine out of twelve delegates of the Board of Directors were present. A quorum is the majority of the voting delegates of the Board of Directors.

1. Minutes from the 8/15/08 meeting were approved.
2. Financial statements dated 10/31/08 were approved.
3. Date for the 2009 State Shoot will be the weekend after the Zone shoot. The 2009 State Shoot will be 8/14-16. The 2009 State Shoot will be a closed shoot.
4. A club must have at least five fields to hold the State Shoot, and be a NSSA and MSSA current member. The price paid to the club will be their normal member round price. The sequence based on a drawing will be 2009 St. Louis, 2010 Poplar Bluff, 2011 Prairie Grove, and 2012 Gateway. The contract between the club and the MSSA is to be finalized and submitted to the MSSA Board for approval on 5/1/09, at the Banquet Shoot.
5. The 2009 Banquet Shoot will be 5/1-3, and will be at Prairie Grove.
6. Club dues will remain at \$50.
7. Member dues will remain at \$8 if paid directly to the Secretary-Treasurer, and \$12 to a club.
8. Member dues are waived for sub-junior shooters, who are under 16 years old on November 1<sup>st</sup>.
9. The next meeting will be on 5/1/09 after the Banquet Shoot shootoffs.
